Dear Valued Customer:

The California Safe Drinking Water and Toxic Enforcement Act of 1986 (commonly known as Proposition 65) requires companies to provide a warning before knowingly exposing California consumers to one of over 900 listed chemicals. California has recently revised the Proposition 65 regulations to reflect that manufacturers have the primary responsibility for providing warnings where required.

As a courtesy to our customers, Kilian Manufacturing Corporation includes the Proposition 65 warnings based on its knowledge of the presence of one or more Proposition 65-listed chemicals such as lead and nickel, which are common elements found in the steel of our products. The warnings are captured on our products without attempting to evaluate the level of exposure, as not all the listed chemicals provide exposure limit requirements. With our products, the exposure may be negligible or well within the “no significant risk” and “maximum allowable dose level” ranges, however, out of an abundance of caution, Kilian has elected to provide the Proposition 65 warnings to ensure compliance.

While we recognize that many of our customers purchase our products outside the State of California (making Proposition 65 inapplicable), it would be extremely difficult to determine which products will be ultimately sold or brought into California. Therefore, to ensure compliance with Proposition 65 requirements, we have chosen to include Proposition 65 warnings on all our products, regardless of destination.

Please note that if you re-sell Kilian products that include a Proposition 65 warning, in order to comply with Proposition 65 you must:

- 1) Provide a compliant website warning for all internet sales.
- 2) Provide a compliant warning for all sales of products that are not sold in their original packaging (e.g. sale or use of individual products that were packaged and labeled in bulk).
